**Conveyance Charges** - Surface waters brought into the District by Landowners

other than District supply will be charged a Conveyance Charge based on

Service Area of delivery as follows:

Lerdo Canal to South Service Area .....	<b>\$46.00 plus 2% loss</b>
South Service Area to North Service Area .....	<b>\$48.00 plus 2% loss</b>
Lerdo Canal to Western Service Area .....	<b>\$68.00 plus 3% loss</b>

### POLICY ITEMS

- Landowner water transfer within District boundaries is allowed.
- Landowner’s well(s) can be pumped into District Distribution Facilities and delivered to same Landowner at different turnouts. The District charges 2% loss and any lift charges if delivered in a different Service Area.
