A. CALL TO ORDER

Mr. Halopoff also provided a verbal update on the Kern Subbasin 2025 GSP TWG budget and the Kern Subbasin LandIQ evapotranspiration (ET) extended services.

1) KNDLA Fourth Amended and Restated JPA

The Board discussed proposed revisions to the KNDLA JPA. After discussion, it was motioned by Director Watkins, seconded by Director Blackwell and unanimously carried, that the version of the KNDLA Fourth Amended and Restated JPA be approved which provided for a withdrawal option.
